# REAL ESTATE THE RITE WAY

**COURSE DESCRIPTION:** The Real Estate the RITE Way course provides students with an extensive introduction to real estate as practiced in the Midlands of South Carolina. Students will gain an understanding of local real estate practices and procedures as they apply to agency, contracts, the closing process, finance, marketing, working with buyers and sellers and prospecting for clients. **The first 30 hours of this 80+ hour course/coaching series meet the State of South Carolina's mandatory continuing education requirements for first year licensees with a Provisional license. As such, South Carolina Law requires attendance of the entire 30 hours in order to receive credit for the course and enable the licensee to upgrade their license.**

**LOCATION:** Russell & Jeffcoat's Training Center, 5219 North Trenholm Road in Forest Acres.

**SCHEDULE:** Weekdays only (Monday to Friday). **Course days begin at 8:30AM.**  
**January 9-20; March 6-16; May 1-11; June 19-29; August 21-31; October 23-November 2**

**COST:** Tuition for the Real Estate the RITE Way course is **\$395**. Tuition fees cover 60 hours of course instruction, course materials, a Listing Presentation book, six additional coaching sessions on prospecting for clients and a course completion certificate required by the Real Estate Commission for license upgrade. **Tuition must be paid in full prior to the course.
